Lily, an orphan living with an older brother, is a 'serial loser' (as is Jarrold), but seeks love and affection where she can find it. As she says, "*Life is full of hard bits, but, in between them is some lovely bits*".

A quirky movie, it has some comedic moments - while the audience at the Midtown Landmark Theatre applauded at the end, this movie was not to my taste.
